A. ACTIVITIES

- 1. The period since the 120th IPU Assembly in Addis Ababa has been taken up with activities to follow up on the results of that meeting, implement the regular programmes of the IPU and prepare for the next session of statutory meetings.
- 2. As can be seen from the list contained in the following section, a large number of conferences, seminars and workshops have or will have been organized by the IPU or held with its support or sponsorship by the time the 121st IPU Assembly starts its proceedings on 19 October. Many of them are reported on in separate documents that will be submitted to the Governing Council in Geneva.
- 3. It is worth highlighting the Parliamentary Conference on the Global Economic Crisis, which the IPU held at the United Nations in Geneva on 7 and 8 May. The meeting, which was the first ever organized of its kind, brought together close to 300 members of parliament from all corners of the globe to discuss their response to the crisis and help develop a parliamentary submission to the United Nations' own conference the following month. The IPU Conference identified a number of steps which parliaments can take to help mitigate the negative effects of the crisis and prevent its recurrence in the future.

Promoting democracy

Assisting parliaments

- 4. The IPU provided technical support to a number of parliaments, including Burundi, Cambodia, Democratic Republic of the Congo, Equatorial Guinea, Maldives, Pakistan and Sierra Leone. Assistance was also extended to the Secretariat of the Palestinian Legislative Council.
- 5. In Burundi, the IPU has continued to promote dialogue between the various parties in parliament as a means of ensuring inclusiveness in decision-making and strengthening reconciliation. In September 2009, it organised a parliamentary retreat for the senior leadership of parliament, as well as leaders of political parties represented in parliament. The retreat reviewed mechanisms for improving dialogue and ensuring fair participation for all members in parliament's work.
- 6. In Cambodia, the IPU worked with UNDP to organize a retreat to build the capacity of the women parliamentarians. The two organizations also held a workshop on 15 September 2009, in celebration of the second International Day of Democracy.
- 7. The IPU and UNDP undertook a number of activities under a joint programme of assistance to the Parliament of the Democratic Republic of the Congo. In June 2009 it held an organisational audit of the administration of both houses of Parliament.
- 8. In the Maldives, the IPU prepared a draft code of ethics for the parliament which is currently under review.

- 9. In Pakistan, the IPU continued its cooperation with the UNDP. In February 2009, a joint mission was undertaken to review activities under the first phase of the project to Strengthen Democracy through Parliament (SDPD). The mission also developed a phase II intended to strategically complement activities achieved during the first phase. The second phase is expected to begin in October 2009.
- 10. In cooperation with the European Commission and UNDP, the IPU organized a mission to the Secretariat of the Palestinian Legislative Council in Ramallah. The mission discussed the details of a future project to strengthen the Secretariat's capacity and effectiveness. A one-year project is being designed to improve the Secretariat's readiness to provide effective service to the PLC upon its resumption. The project will be implemented in cooperation with UNDP and funded by the European Commission.
- 11. In Sierra Leone, the IPU continued to assist the Parliament with the drafting of its strategic plan. Efforts were also devoted to the finalisation of a project document to be implemented in cooperation with UNDP.
- 12. The IPU fielded a fact-finding mission to the Parliament of Zimbabwe in May 2009. The mission was designed to identify areas where the IPU could support the Parliament in the context of the ongoing reconciliation process as well as in the day-to-day functioning of the parliament. A second mission was undertaken in September by the IPU Secretary General, to agree the details of such support. A project proposal is expected to be submitted to the authorities of the Parliament.
- 13. The IPU and the World Bank Institute (WBI) joined forces to develop and deliver, through distance learning technologies, a course for *Parliaments in Conflict Affected Countries*. The first session of the course took place in May 2009, with the participation of the Parliaments of Liberia and Sierra Leone and the South Sudan Legislative Assembly.

Human rights

- 14. The human rights programme was servicing the Committee on the Human Rights of Parliamentarians in preparation for and follow-up to its last session that was held from 28 June to 1st July in Geneva. At that session, the Committee examined 62 cases, four of which for the first time. It also held five hearings with the sources in some of the cases. At the session in July, the Committee's total case-load concerned 262 parliamentarians in 30 countries.
- 15. At its July session, the Committee considered that the seriousness and complexity of the many cases it is examining in Colombia warranted an on site mission to Colombia. It asked its Vice-President, Senator Rosario Green, of Mexico, and the Secretary General to carry out this mission. They consequently travelled to Bogota, where they met, from 22 to 24 August, with the President of the Republic and Ministers of his Cabinet, the Presidents of the Colombian Senate and House of Representatives, the President of the Supreme Court, and the Prosecutor General and Attorney General of Colombia. They also met with current and former members of Congress who are under threat and with family members of those who were assassinated. The discussions focused on encouraging progress in the investigations into the murder of parliamentarians, strengthening protection for those at risk and ensuring full respect for the right to fair trial for members of congress. The delegation will present its findings and recommendations to the Committee at its next session in October.

- 16. As part of a capacity-building project it launched in June 2008 to enable parliaments to become fully involved in the process of national reconciliation and institutional reform, the IPU organized several national seminars following the regional seminar held in Sierra Leone in June 2008. These parliamentary events provided the participants with an opportunity to assess the major challenges facing them and identify ways and means of addressing them.
- 17. A national seminar for parliamentarians was held from 29 to 30 April 2009 in Freetown, Sierra Leone. The participants set themselves specific objectives based on concrete recommendations. In order to achieve those objectives, measures and implementation deadlines were identified. A steering committee was set up to that end.
- 18. A regional conference was held from 13 to 14 July 2009 at the Rwandan Parliament in Kigali. The meeting brought together members of parliament from Burundi, Democratic Republic of the Congo, Kenya, Rwanda and the United Republic of Tanzania.
- 19. On 16 September, the IPU co-organized with the Friedrich Ebert Foundation a parallel event at the 12th session of the United Nations Human Rights Council on "The role of parliaments in the Universal Periodic Review". The panel, which was attended by representatives of Permanent Missions to the United Nations in Geneva and members of non-governmental organizations gave rise to an interesting debate from which it clearly emerged that, for this new process to become an effective instrument for the promotion and protection of human rights, the involvement of parliaments will be crucial.
- 20. In cooperation with the International Labour Organization and the Office of the UN High Commissioner for Human Rights, the IPU is preparing a handbook for parliamentarians on migration and human rights. A first draft has been prepared and is currently under review. The handbook should be published by the end of this year.

Women in politics

- 21. In partnership with the Parliament of Burundi, the IPU concluded a two year project in support of women parliamentarians, funded by the United Nations Democracy Fund. The most recent activities were aimed at supporting parliamentary action in the area of implementing the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW). Activities were held to inform parliamentarians about obligations and rights contained in the Convention, pinpoint discriminatory laws and devise parliamentary action. A survey was also conducted on the legislative priorities of women MPs and its results discussed with civil society organizations. The project ended with the discussion of a plan of action for the Burundian Parliament on equality and women's rights in Burundi.
- 22. The IPU and UNDP Jordan signed a Memorandum of Understanding aiming to support the House of Representatives of Jordan to promote women in parliament and respect for women's rights. As part of the activities included in the joint programme of cooperation, a seminar on budget and equality was held in July 2009. The programme also helped establish a working group to review and repeal discriminatory provisions in Jordanian laws to comply with the provisions of the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW).

- 23. The Fifth Meeting of Women Speakers of Parliament was held in July 2009, organized by the IPU and hosted by the Austrian National Council. It addressed challenges encountered in achieving Millennium Development Goal (MDG) 3 to promote gender equality, in particular violence against women and the financial crisis. The Speakers also signed up to UNIFEM's Say NO to Violence against Women Campaign.
- 24. The IPU presented a report to the United Nations Committee on Discrimination against Women, meeting in New York in July. The report provided information on women in parliament in the respective countries considered at the session and on the level of parliamentary involvement in the CEDAW reporting process.
- 25. Work was pursued on IPU's latest research project on Gender Sensitive Parliaments Survey. Survey questionnaires were sent to parliamentary authorities, members of parliament and parliamentary groups.
- 26. The IPU launched its parliamentary campaign to end violence against women. It created a section on its website on the campaign (http://www.ipu.org/vaw), brought out a publication on parliament's role in ending violence against women and produced campaign material to support parliaments in marking the 10th anniversary of the formal proclamation of 25 November as International Day for the Elimination of Violence against Women.
- 27. The IPU has again contributed to the Millennium Development Goals Report and the UNDP Human Development Report, providing data on the number of women in parliament, as it does every year. Research on the functioning of parliamentary committees that deal with gender equality and the status of women has been broadened in scope to include parliamentary caucuses of women parliamentarians. Finally, the IPU took part in a Regional Conference on Women in Parliament in Arab States, organized by UNDP in Beirut, Lebanon, in July.
- 28. The IPU has continued to collaborate in the International Knowledge Network of Women in Politics (www.iKNOWPolitics.org) along with its partners, the United Nations Programme for Development (UNDP), the United Nations Development Fund for Women (UNIFEM), the International Institute for Democracy and Electoral Assistance (International IDEA) and the National Democratic Institute for International Affairs (NDI).

Child related activities

29. At a seminar hosted by the Legislative Assembly of Costa Rica and organized by the IPU and UNICEF, parliamentarians from 14 Latin American countries came together to discuss strategies to prevent and eliminate violence against children. The participants adopted recommendations for parliamentary action on aspects of violence prevention and elimination.

Development issues

30. The IPU continued to follow up on the resolution adopted in Cape Town in 2008 on "Parliamentary oversight of State policies on foreign aid". It worked with the Development Cooperation Forum (DCF) of the United Nations Economic and Social Council in its efforts to improve the effectiveness of development cooperation. The IPU is also a member of the OECD-led Working Party on Aid Effectiveness that monitors progress towards achieving the objectives of the Paris Declaration and the Accra Agenda for Action. The IPU co-chairs a working group on promoting domestic accountability towards greater aid effectiveness.

- 31. Case-studies undertaken by the IPU during the year reviewed the level of parliamentary involvement in planning and assessing national development plans and programmes in Tanzania and Zambia. The aim of the studies is to inform how best to enable parliaments to assume responsibility and take ownership of development plans and their implementation.
- 32. During the past few months the IPU has begun supporting a new project in the Asia-Pacific region, the facility for Capacity Development for Development Effectiveness (CDDE). Headed by the United Nations Development Programme (UNDP), the Asian Development Bank (ADB), the World Bank Institute (WBI), and the Organisation for Economic Co-operation and Development (OECD), the CDDE aims to develop capacities for aid effectiveness by bringing together MPs, civil society representatives, donors and government ministries.

Cooperation with the United Nations System

- 33. The IPU participated in the United Nations Conference on the Financial Crisis and its impact on Development on 20-26 June. The Outcome Document of the UN conference encouraged the IPU "to continue to contribute to the development of global responses to the crisis".
- 34. A preparatory committee for the 3rd World Conference of Speakers of Parliament in July 2010 met at IPU Headquarters on 17-18 July. The 25 Speakers on the Committee decided inter alia that the parliamentary Summit would look at ways of further strengthening the UN-IPU partnership and that its outcome would be presented to the United Nations 2010 Summit in September of the same year.
- 35. On 24 September, the IPU held a briefing in New York for members of parliament attending the General Debate at the opening of the 64th session of the United Nations General Assembly.
- 36. Preparations began for the 2009 Parliamentary Hearing at the United Nations (19-20 November) entitled "The Way Forward Building political support and implementing effective responses to the global economic crisis", the 4th United Nations Conference on the Least Developed Countries in 2011, and for the fifteenth session of the Conference of the Parties (COP15) of the United Nations Framework Convention on Climate Change (UNFCCC), taking place in Copenhagen in December 2009.
- 37. In order to better reflect the level of cooperation between the IPU and UNDP, the Secretary General and the UNDP Administrator began talks on reviewing and updating the Memorandum of Understanding signed by the two Organizations in 2007.
- 38. In addition to the foregoing activities, on 30 September 2009 the IPU organized, within the framework of the annual WTO Public Forum, a panel discussion on the dangers of trade protectionism as a policy response at the time of the global economic crisis. On the following day, the IPU hosted a session of the Steering Committee of the Parliamentary Conference on the WTO which focused on the current situation in the Doha Round of multilateral trade talks.

Administration and Finance

- 39. During the first half of 2009, the world economy continued to suffer from the effects of the global financial crisis that began in the latter part of 2008. In terms of foreign exchange rates, the main budgetary impact of differences in the USD/CHF rate arises from the IPU New York office. The US dollar showed some recovery during the first quarter, but has weakened again significantly, thereby providing a favorable impact against overall operating expenses. Swiss inflation, as well as that of most countries, remains relatively benign as commodity prices have dropped in the wake of the economic recession. With operating expenditures being kept within the budgetary appropriations, the financial situation appears stable and healthy with an operating surplus being projected at the year's end.
- 40. The primary concern for the IPU in the medium term remains the liability in relation to the pensions of former employees. The recovery in the equity and bond markets enabled the pension fund to recover significantly from the market lows recorded in February/March 2009. Members must remain aware of the Organization's obligation to provide sufficient funding in order to meet the pension obligations of its former staff members.
- 41. As regards assessed contributions, some Members have not paid their contributions and, as a result, may lose their voting rights or be suspended from affiliation to the Union. In preparation of this, the IPU has foreseen appropriate provisions in its doubtful account reserve.
- 42. Sustained efforts to mobilize voluntary funds for the IPU have resulted in project funds being secured from Finland for human rights activities, from UNDP for various projects and from the European Commission for a parliamentary project in Equatorial Guinea. Additional funds are being negotiated with the Belgian Government for activities in West Africa in cooperation with the Sahel and West Africa Club (SWAC).
