## AMENDMENTS TO THE IPU STATUTES AND RULES

1. At its $192^{\text {nd }}$ session (Quito, March 2013), the Governing Council endorsed a set of proposals to modify the format of IPU Assemblies, improve the functioning of the Standing Committees and their Bureaux, and place the Committee on United Nations Affairs on an equal footing with the Standing Committees (see CL/192/8(b)-P.1). The decision of the Governing Council had been preceded by a series of multi-format consultations among IPU M embers carried out in the period 2006-2012 and finalized during the session in Q uito.
2. Practical implementation of the decision taken by the Governing Council requires a number of amendments to be made to the Statutes, the Rules of the Assembly, the Rules of the Standing Committees, the Rules of the Meeting of W omen Parliamentarians and the Rules of the Coordinating Committee of Women Parliamentarians. An aggregate table of these amendments, as reviewed by the Executive Committee via correspondence in June 2013, is to be found in the Annex. Section A contains amendments deriving from the decision of the Governing Council, while Section B lists a number of additional amendments that are necessary to align the Statutes and Rules with current practice (preparation of the Assembly summary records, annual reporting exercise by M embers, etc.).
3. The scope of amendments being exceptionally wide, they have been grouped by subject (Sessions and functioning of the Assembly; Sessions and functioning of the Standing Committees; Committee on UN Affairs; Bureaux of the Standing Committees; Selection of subject items for discussion by Standing Committees at future Assemblies; Rapporteurs; M eeting of W omen Parliamentarians; Committee on the Human Rights of Parliamentarians; Forum of Young Parliamentarians; and Miscellaneous) and numbered for ease of reference.
4. The overall purpose of each proposed amendment is outlined in a brief introduction appearing in the table as a grey box entitled "Description of the modification". The actual text of each amendment starts with an indication of the Article or Rule to which it refers and is presented with revision marks (deleted text is stricken through, new wording is in bold).
5. At its sitting on 9 October, the Governing Council will express an opinion on the proposed amendments to the IPU Statutes and will adopt amendments to the Rules of the Standing Committees. Also on 9 October, the Assembly will adopt amendments to the IPU Statutes and the Rules of the Assembly. Given the fact that the Meeting of Women
Parliamentarians will not be holding a session in October and that the related amendments will only become operational at the second Assembly of 2014, the proposed amendments to the Rules of the Meeting of Women Parliamentarians and the Rules of the Coordinating Committee of Women Parliamentarians will only be adopted at the $130^{\text {th }}$ IPU Assembly in April 2014.
6. Procedural aspects differ depending on the category of amendments concerned, the IPU bodies that are responsible for the adoption of amendments and the type of majority vote that are required for adoption. More specifically:
(a) Amendments to the Statutes are adopted by the Assembly by a two-thirds majority vote after hearing the opinion of the Governing Council expressed through a simple majority vote (cf. Statutes, Art. 28.1 and 28.3). Sub-amendments are receivable up to six weeks before the meeting of the Assembly (cf. Statutes, Art. 28.2), i.e. by 26 August 2013.
(b) Amendments to the Rules of the Assembly are adopted by the Assembly itself by a majority of the votes cast (cf. Assembly Rule 40.1). Sub-amendments are receivable up to one month before the meeting of the Assembly (cf. Assembly Rule 40.2), i.e. by 7 September 2013.
(c) Amendments to the Rules of the Standing Committees are adopted by the Governing Council by a majority of the votes cast (cf. Standing Committees, Rules 35.1(c) and 38). Sub-amendments are receivable until one month before the meeting of the Governing Council (cf. Standing Committees, Rule 38.2), i.e. by 7 September 2013.
(d) Amendments to the Rules of the Meeting of Women Parliamentarians are approved by the Governing Council by a two-thirds majority vote after hearing the opinion of the Meeting of Women Parliamentarians expressed through a simple majority vote (cf. Meeting of Women Parliamentarians, Rules 38.3, 38.4 and 38.6). During the vote in the Governing Council, the number of affirmative votes must be equal to at least one-third of the total number of Governing Council members or their substitutes actually participating in the session (cf. Council, Rule 35.3). Sub-amendments are receivable up to one month before the sessions of the Meeting of Women Parliamentarians and the Governing Council (cf. Meeting of W omen Parliamentarians, Rule 38.2).
(e) Amendments to the Rules of the Coordinating Committee of Women Parliamentarians are adopted by the Coordinating Committee itself, by a majority of the votes cast by the members or substitutes present at the time of voting (cf. Coordinating Committee of Women Parliamentarians, Rule 17.2) and approved by the Meeting of Women Parliamentarians by a majority of the votes cast (cf. M eeting of W omen Parliamentarians, Rules 23.1). Sub-amendments are receivable up to three months before the session of the Coordinating Committee (cf. Coordinating Committee of W omen Parliamentarians, Rule 17.2).
7. The approval of proposed amendments will lead to a renumbering of paragraphs and the readjustment of cross-references throughout the text of the Statutes and Rules.

## Rule 10.1

The agenda of the Assembly, approved on the occasion of its previous session, shall include a General Debate with an overall theme, and one-normally two subject items proposed by theeach Standing Committees and relating to its-their own field of competence (cf. Standing Committees, Rule 6.1 and Statutes, Art. 14.1) as well as possible reports submitted by the Standing Committees.
Rule 15.3 3. The three subject items placed by the Assembly on its agenda shall be debated by the competent Standing Committees, each of which shall prepare a report and a-draft resolutions for consideration by the Assembly (cf. Statutes, Art. 13.2).

## Description of the modification:

The rapporteurs are expected to prepare a succinct action-oriented draft resolution accompanied by an explanatory memorandum. Members of the Union may provide written inputs for the rapporteurs to take into account in their work. Such inputs must be brief and be submitted in one of the official languages of the IPU.
Note: Related amendments already appear under section 2.1 above.

## Rules of the Assembly

## Rule 13

As a rule, the Assembly will appoint two rapporteurs for each subject item proposed by a Standing Committee, who will prepare a succinct action-oriented draft resolution and an accompanying explanatory memorandumreport or reports on the item placed on their Committee's agenda. M embers of the U nion may contribute to such reportsthe drafting process by submitting their brief written inputs in one of the official languages of the IPU (cf. Assembly, Rule 37.1)-suggestions and comments to the rapporteurs. The arrangements for the submission of such suggestions and commentsinputs shall be indicated in the convocation of the Assembly (cf. Standing Committees, Rule 12).

## Rule 14.1

 1. The rapporteurs will also prepare a draft resolution on the subject included on the agenda of their Committee. [ Deletion of the Rule ]Rule 17.1 1. Any delegate may submit amendments relating to the draft resolutions prepared by the rapporteurs on the subject item included in the agenda approved by the Assembly. They shall be deposited with the IPU Secretariat of the Assembly no later than 15 days before the opening of the Assembly. However, the M eeting of Women Parliamentarians shall be permitted to submit amendments incorporating a gender perspective at any time prior to the closure of the first sitting of the respective Standing Committee. This Rule shall apply to the Coordinating Committee of Women Parliamentarians at the second Assembly of the year (cf. Standing Committees, Rule 12.2).

## Rules of the Standing Committees

## Rule 12.1

1. The Assembly shall appoint rapporteurs for each subject item proposed by the Standing Committees, who will prepare a succinct action-oriented draft resolution and an accompanying explanatory memorandum report or reportson the item placed on their Committee's agenda. Members of the U nion may contribute to the drafting process such reportsby submitting their brief written inputs in

The deadline for the submission of proposals is 15 days before the opening of the Assembly preceding the one where the subject is to be discussed. |  |

## RULE 16bis

Any Member of the Union may submit a proposal for a subject item to be discussed by a Standing Committee at a future Assembly. Such proposals shall be deposited with the Secretariat of the Union no later than 15 days before the opening of the Assembly preceding the one where the subject will be discussed.

## Description of the modification:

A Standing Committee takes decisions concerning subject items to be discussed at future Assemblies on the recommendation of its Bureau. When the Committee is called to take the decision, the only proposals in order, other than those included in the recommendation of the Bureau, shall be earlier proposals submitted within the statutory deadlines but not accepted by the Bureau. If such a proposal is resubmitted, the Committee will first decide whether to consider it.

## New Rule 16ter <br> RULE 16ter

16ter.1. A Standing Committee shall decide on the subject item to be proposed for discussion at the next Assembly (cf.
Assembly, Rule 15.3) after hearing the recommendation of its Bureau.
16ter.2. When the Committee is called upon to take a decision on the subject item to be proposed for discussion at the next Assembly, the only proposals in order, other than those included in the recommendation of its Bureau, shall be earlier proposals submitted within the statutory deadlines (cf. Rule 16bis.1) but not accepted by the Bureau.
16ter.3. If a Standing Committee receives a request from a Member of the Union to consider a proposal that was not accepted by the Bureau, the Standing Committee shall first decide whether to consider such a request.

## Description of the modification

The authors of a proposal for a subject item are entitled to present it in person to the Bureau, which will consider all such proposals and formulate a relevant recommendation to the Standing Committee. A Bureau member cannot present a proposal on behalf of a delegation. When considering the proposals, the Bureau may combine two or more suggestions into a single proposal, put forward another subject item or decide to submit more than one proposal for the Standing Committee to choose from

## New Rule 16quater

## RULE 16quater

16quater.1. The Bureau shall consider all duly submitted proposals for subject items to be discussed at future Assemblies and shall formulate its recommendation to the Standing Committee.
16quater.2. The authors of proposals (cf. Rule 16bis.1) shall be invited to present them to the Bureau.
16quater.3. A member of the Bureau cannot present a proposal on behalf of a delegation.
16quater.4. When considering the proposals for subject items to be discussed at future Assemblies, the Bureau may choose one of the proposals, combine two or more of them into a single item, put forward another subject item or decide to submit more than one proposal to the Standing Committee.

## Description of the modification:

The Bureau of a Standing Committee may transmit to the Bureau of another Standing Committee its suggestions for subject items to be discussed by those Committees at future Assemblies.

New Rule 16quinquies

## RULE 16quinquies

The Bureau of one Standing Committee may convey to the Bureau of another Standing Committee its suggestions for subject items to be discussed by that Standing Committee at future Assemblies.

## 6. Rapporteurs

## Rules of the Standing Committees

6.1 Description of the modification:

In the appointment of rapporteurs, every effort will be made to respect the principle of gender equality and ensure the representation of young parliamentarians.
New Rule 12.3 12.3 The appointment of rapporteurs shall take into account the principles of gender equality and equitable geographical distribution. Every effort shall be made to include young parliamentarians among the rapporteurs.
6.2 Description of the modification

If it proves to be impossible to appoint one or more rapporteurs before the end of the Assembly preceding the one where the subject is to be discussed, the President of the IPU shall be given the mandate to pursue consultations with a view to appointing the rapporteurs at the earliest possible opportunity.
New Rule 12.4
12.4 If at least one rapporteur is not appointed before the end of the Assembly preceding the one where the subject is to be discussed, the President of the IPU shall be entrusted with pursuing consultations with a view to appointing these rapporteurs at the earliest possible opportunity.

## 7. Meeting of Women Parliamentarians

### 7.1 $\quad$ Description of the modification:

A M eeting of Women Parliamentarians will take place at every session of the Assembly.
Note: Related amendments also appear under sections 2.2 above.

## Statutes
