# Convocation of the 200<sup>th</sup> session of the Governing Council of the IPU

Dhaka, 2 and 5 April 2017

Madam President, Mr. President,

We have pleasure in informing you that the Governing Council of the Inter-Parliamentary Union will hold its 200<sup>th</sup> session at the Bangabandhu International Conference Center (BICC) in Dhaka, Bangladesh.

## 1. PARTICIPATION

The Governing Council is composed of three members from each parliament represented in the IPU. Each parliament's representation on the Governing Council must include both men and women. Single-gender delegations will be limited to two members (Rule 1.2 of the Rules of the Governing Council).

The first sitting of the Governing Council will take place on Sunday, 2 April from 9 to 10.45 a.m. The second sitting will be held on Wednesday, 5 April, from 9.30 a.m. to 1 p.m. and from 2.30 to 5 p.m.

## 4. SUPPLEMENTARY ITEMS

In conformity with Governing Council Rule 13, members of the Council may request the inclusion of supplementary items in the agenda. Such items must fall within the mandate of the Council which, according to Article 20 of the Statutes, determines and guides the activities of the IPU and controls their implementation.

Any requests for the inclusion of supplementary items will be immediately transmitted by the Secretariat to all Council members. After hearing the opinion of the Executive Committee, the Council shall decide on such a request by a majority of votes cast if the request is received by the Secretariat at least 15 days before the opening of the session; otherwise by a two-thirds majority.

## 5. DOCUMENTS

To the extent possible, working documents regarding various items of the provisional agenda will be sent out to Members and posted on the IPU website in advance.
