VACANCIES TO BE FILLED DURING THE 121st ASSEMBLY

EXECUTIVE COMMITTEE

On 21 October 2009, the Governing Council will be required to elect **five members** to fill the following seats on the Executive Committee.

Asia-Pacific Group

Two vacancies [Mr. A. Toha (Indonesia), who is no longer a member of parliament and whose Executive Committee term ends in October 2010; Mr. Ngo Anh Dzung (Viet Nam), who has been appointed Ambassador and whose Executive Committee term ends in October 2011].

To date, the following candidature has been received for the vacancies corresponding to this geopolitical group:

- Mr. Ngo Quang Xuan (Viet Nam): candidature submitted by the Vietnamese Inter-Parliamentary Group.

Twelve-Plus Group: Two vacancies [expiry of the term of office of

Ms. E. Papademetriou (Greece); and vacancy of the seat of Ms. A. Möller (Iceland), who is no longer a member of parliament, and whose Executive Committee term ends in

April 2012].

Eurasia Group : One vacancy [expiry of the term of office of

Mr. A. Kozlovskiy (Russian Federation)].

Candidatures from the corresponding regions, accompanied by a signed covering letter and a brief curriculum vitae (one page maximum), may be submitted up to Tuesday, 20 October, by 2.30 p.m.

SUBSIDIARY BODIES OF THE GOVERNING COUNCIL OF THE INTER-PARLIAMENTARY UNION

Committee on Middle East Questions

On 21 October, the Governing Council will be required to elect **one titular member** and **three substitute members** to replace:

- (i) Mr. M. El Feki (Egypt), whose term of office expired at the 184th session (April 2009);
- (ii) Mr. L.H. Ishaaq (Indonesia), who was elected titular member at the 184th session; and

Group of Facilitators for Cyprus (ad hoc)

On 21 October, the Governing Council will be required to elect **one facilitator**, a vacancy not filled at the 184th session.

Candidatures, accompanied by a signed covering letter and a brief curriculum vitae (one page maximum), may be submitted up to Tuesday, 20 October 2009, by 9 a.m.

APPOINTMENT OF TWO INTERNAL AUDITORS FOR THE 2010 ACCOUNTS

On 21 October, the Governing Council will appoint **two Internal Auditors** for the 2010 fiscal year. They will report in spring 2011. Parliamentarians interested in submitting their candidature for this position should preferably have prior experience either in a parliamentary finance or audit committee.

Candidatures, accompanied by a signed covering letter and a brief curriculum vitae (one page maximum), may be submitted up to Tuesday, 20 October, by 2.30 p.m.
