Panel discussion on Nuclear Weapons - The Road to Zero

Monday, 17 October, 10.30 a.m. – 1 p.m.

Introduction

In 2009 the IPU Assembly adopted by consensus a comprehensive resolution on advancing nuclear non-proliferation and disarmament and securing the early entry into force of the Comprehensive Nuclear-Test-Ban Treaty (see http://www.ipu.org/conf-e/120/120-1.htm). The resolution includes many practical recommendations on what parliaments should do to ensure universal ratification of CTBT, promote the UN Secretary-General's five-point plan for nuclear disarmament, and support a number of concurrent steps such as reductions in nuclear stockpiles, establishment of nuclear-weapon-free zones, and commencement of negotiations on a fissile materials treaty and a comprehensive nuclear weapons convention.

Last year, several parliaments reported on steps they were taking to implement those recommendations. Others are being encouraged to follow suit, and several Member Parliaments continue to attach great importance to the issue of nuclear disarmament and non-proliferation. The panel discussion in Bern aims to enhance political support and further mobilize parliamentary action to meet the goal of a nuclear weapon-free world.

Segment 1 (10.30 – 11.45 a.m.)

This segment will focus on the new visions, policies and proposals that have been put forward to address the threats and challenges posed by nuclear weapons. It will serve to provide an overview of these proposals, focusing on approaches to achieve zero nuclear weapons, including from a humanitarian perspective.
