### PREAMBLE

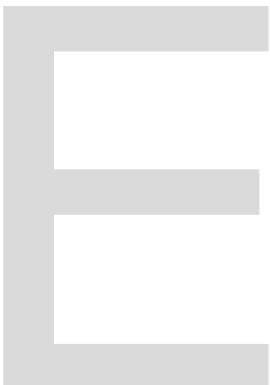
New preambular paragraphs 2bis and 2ter

Add two new paragraphs after preambular paragraph 2 to read as follows:

**(2bis) *Recalling also* that the right to water is clearly essential to secure an adequate standard of living, particularly since it is one of the most fundamental conditions for survival, that it is inextricably related to the rights to the highest attainable standard of health and to adequate housing and food, and that it should be seen in conjunction with other rights enshrined in the International Bill of Human Rights, foremost among them the right to life and human dignity,**

**(2ter) *Recalling further* the Universal Declaration of Human Rights, the International Covenant on Economic, Social and Cultural Rights, the International Covenant on Civil and Political Rights, the International Convention on the Elimination of All Forms of Racial Discrimination, the Convention on the Elimination of All Forms of Discrimination against Women, the Convention on the Rights of the Child and the Convention on the Rights of Persons with Disabilities,**

Preambular paragraph 3

Amend to read as follows:

(3) *Having considered* United Nations General Assembly resolutions 64/292 of 28 July 2010 (in which the right to safe and clean drinking water and sanitation is recognized as a human right essential for the full enjoyment of life), and 68/157 of 18 December 2013, **68/118 of 16 December 2013 (on the law of transboundary aquifers) and 69/215 of 19 December 2014 (on the International Decade for Action, "Water for Life", 2005–2015, and further efforts to achieve the sustainable development of water resources), General Comment No. 15 of the Committee on Economic, Social and Cultural Rights (on the right to water),** and Human Rights Council resolution 27/7 of September 2014,

(3) *Having considered* United Nations General Assembly resolutions 64/292 of 28 July 2010 (in which the right to safe and clean drinking water and sanitation is recognized as a human right essential for the full enjoyment of life **and all human rights**) and 68/157 of 18 December 2013, and Human Rights Council resolution 27/7 of September 2014,

(5) *Deeply concerned* by the increased pressure being exerted on water resources by factors such as population growth, climate change, rapid urbanization, **the growing needs of modern agriculture,** growing energy demand and lack of effective governance,

(6) *Equally concerned* by the fact that water scarcity is already affecting one in three people on every continent, ~~and~~ that by 2025 two thirds of the world's population will be under water stress and 1.8 billion people will face absolute water scarcity, **and that, as a result of climate change, regions inhabited by more than 2 billion people around the world are threatened with drought,**

(7) *Also deeply concerned* at the fact that ~~748~~ **around 700** million people lack access to an improved drinking water source, that, **according to the 2014 report of the WHO/UNICEF Joint Monitoring Programme for Water Supply and Sanitation, more than one third of the global population (2.5 billion people)** still lacks access to improved sanitation, ~~and~~ that 1 billion people still practice open defecation, **and that the world is not on track to meet the sanitation component of Millennium Development Goal 7, which calls for halving the proportion of the population without sustainable access to an improved sanitation facility,**

(7) *Also deeply concerned* at the fact that 748 million people lack access to an improved drinking water source **of supply**, that 2.5 billion people still lack access to improved sanitation and that 1 billion people still practice open defecation,

Preambular paragraph 8

Replace the existing text of preambular paragraph 8 by the following:

(8) **Concerned that the official figures do not capture all the dimensions of drinking water safety, affordability of services and safe management of excreta and waste water, and therefore underestimate the numbers of those without access to safe and affordable drinking water and safely managed and affordable sanitation; highlighting in this context the need to adequately monitor drinking water safety and sanitation management in order to obtain data that capture those dimensions as a critical step towards securing access to safe drinking water and the safe management of sanitation,**

Add a new paragraph after preambular paragraph 8 to read as follows:

**(8bis) Reaffirming that non-discrimination and equality are fundamental human rights principles, and that inequalities in the realization of the right to safe drinking water and sanitation persist, inter alia between urban and rural areas and with respect to groups such as refugees and asylum-seekers, and insisting that targeted measures must be adopted to progressively eliminate such inequalities, with a specific focus on gender, persons with disabilities and children,**

(10) **Affirming the importance of regional and international technical cooperation, where appropriate, as a means of promoting the progressive realization of the human right to safe drinking water and sanitation, without prejudice to questions of international water law, including international watercourse law,<sup>1</sup>**

Amend to read as follows:

1. *Calls on* national parliaments to advocate a dedicated comprehensive water and sanitation goal in the post-2015 development agenda, so as to ensure the availability and sustainable management of water and sanitation for all, ~~said goal to include concrete actions and in particular the development of an efficient monitoring system with global indicators;~~

1. *Calls on* national parliaments to advocate a dedicated comprehensive water and sanitation goal in **the preparation of** the post-2015 development agenda, so as to ~~ensure the availability~~ **achieve universal and equitable access to** and sustainable management of water and sanitation for all, said goal to include concrete actions ~~and in particular the development of an efficient monitoring system with global indicators,~~ **targets and indicators that are universally applicable and take into account differing national realities, capacities and levels of development and respect national policies and priorities;**

1. *Calls on* national parliaments to advocate a dedicated comprehensive water and sanitation goal in the post-2015 development agenda, so as to ensure the availability and sustainable management of water and sanitation for all, said goal to include concrete actions and in particular the development of an efficient monitoring system with global indicators, **and further to advocate an influential role for parliamentarians in the international climate change instrument to be adopted at the 21<sup>st</sup> session of the Conference of the Parties to the United Nations Framework Convention on Climate Change;**

Amend to read as follows:

Amend to read as follows:

3. *Urges national parliaments to set aside adequate budget allocations for multilevel and efficient governance, and to establish legislative and regulatory frameworks encouraging **dialogue and partnerships between the public and private investment sectors in order to stimulate investment** in the water sector;*

Amend to read as follows:

3. *Urges national parliaments to set aside adequate budget allocations for multilevel and efficient ~~governance~~ **integrated water management**, and to establish legislative and regulatory frameworks encouraging public ~~and private~~ investment in the water sector;*

### New operative paragraph 3bis

Add a new paragraph after operative paragraph 3 to read as follows:

- 3bis. Urges national parliaments to approve comprehensive and integrated laws so as to encourage conservation, spur innovation and ensure sustainable use of water and energy in their respective countries;**

Operative paragraph 5

Amend to read as follows:

First proposal:

5. *Encourages* States sharing water resources to cooperate on matters relating to international watercourses and ~~seriously to consider joining international legal frameworks for transboundary water cooperation~~;

Second proposal:

5. *Encourages* States sharing water resources to cooperate on matters relating to international watercourses, and ~~seriously to consider joining international legal frameworks for~~ **deal with transboundary water cooperation affairs on an equitable and reasonable basis**;

**5bis. *Calls upon* States and international organizations to provide financial resources, capacity-building and technology transfer, through international assistance and cooperation, in particular to developing countries, in order to scale up efforts to provide safe, clean, accessible and affordable drinking water and sanitation for all;<sup>2</sup>**

6. *Encourages* national parliaments to urge their governments to honour the commitments their countries have made in regard to the protection of freshwater sources, **to adopt legislative measures for the implementation of the right to safe drinking water and sanitation, and to ensure that effective remedies for violations of their obligations regarding that right, including judicial, quasi-judicial and other appropriate remedies, are accessible to everyone, without discrimination;**

Add a new paragraph after operative paragraph 6 to read as follows:

**6bis. *Invites* parliamentarians to support and promote policies and measures to increase cooperation at regional and international level, with a view to supporting developing country efforts to improve water efficiency in agriculture, the promotion of water management and adequate allocation of capacities, adaptation to climate change and easing of related vulnerabilities, and the development and sharing of innovative water efficiency technologies;**

Add a new paragraph after operative paragraph 6 to read as follows:

**6bis. *Calls on* parliamentarians to support and strengthen the participation of local communities in improving water and sanitation management;**

Add a new paragraph after operative paragraph 6 to read as follows:

**6bis. *Calls on* parliamentarians to attach importance to fostering dialogue and effective cooperation between parliaments, civil society organizations, the private sector and the representatives of residential areas on water resource planning and the establishment of executive mechanisms of action to implement the principles of integrated water resource management;**

Amend to read as follows:

7. *Requests* the IPU to draft a compilation of best legal and policy practices related to human rights-based water management, **including the UNDP Water Governance Facility at the Stockholm International Water Institute and UN-Water programmes such as the Water for Life Decade**, in order to support the work of parliamentarians involved in water-related issues;

*(Bahrain)*

Amend to read as follows:

7. *Requests* the IPU to draft a compilation of best legal and policy practices related to ~~human rights-based~~ **integrated water resource** management, in order to support the work of parliamentarians involved in water-related issues;

*(India)*

New operative paragraph 8bis

Add a new paragraph after operative paragraph 8 to read as follows:

**8bis. Urges all States, in particular those able to do so, and international financial institutions to allocate adequate financial resources and technical assistance to the implementation of national laws and regulations and bilateral and multilateral agreements between States, in order to promote local, national and regional water-related cooperation.**

*(Islamic Republic of Iran)*

Add a new paragraph after operative paragraph 8 to read as follows:

**8bis. Calls for an international workshop to be convened at which water management experts, along with parliamentarians and representatives of international and regional entities, would prepare an international parliamentary guide on the optimal use and management of water resources in accordance with the new concepts, said guide to include a simplified explanation of the fundamental legislation parliaments must take into account in terms of water and food and environmental security policies, to propose a model of action on parliamentary policies to maximize agreement on programmes related to good management of water, the environment, and food security during the discussion of government plans and programmes, budgets and oversight measures, and to incorporate the global good practices and experiences recommended in this regard.**
