It is our pleasure to inform you that the 132<sup>nd</sup> Assembly of the Inter-Parliamentary Union and related meetings will be held at the National Convention Centre (NCC), Hanoi (Viet Nam) from Saturday, 28 March to Wednesday, 1 April 2015.

#### **TIMETABLE**

The Timetable of the Assembly and related meetings is set out in <u>Annex 1</u>. The Inaugural Ceremony will take place on Saturday, 28 March 2015 at 8 p.m., at the National Assembly of Viet Nam.

The Governing Council will convene on 29 March and 1 April and will consider and take decisions on a host of matters relating to the functioning and activities of the IPU, implementation of the IPU Strategy for 2012-2017, cooperation with the United Nations and future initiatives. The Assembly, at its sittings on 31 March and 1 April, will adopt resolutions on the emergency item chosen for the Hanoi Assembly, as well as on the subject items taken up by the Standing Committees. It is expected that the Assembly will conclude with an outcome document on the theme of its General Debate, and that it will wrap up its business by 6.30 p.m. on Wednesday 1 April.

#### **EMERGENCY ITEM**

According to Assembly Rule 11.1 and Article 14.2 of the IPU Statutes, any Member of the IPU may request the inclusion of an emergency item in the Assembly agenda. If the Assembly so decides, the emergency item will be debated by the Assembly in the morning of Monday, 30 March 2015. Provision has also been made that same afternoon for a drafting committee to meet in order to prepare a draft resolution.

Members are reminded that all requests for the inclusion of an emergency item must relate to a major event of international concern on which it appears necessary for the IPU to express an opinion. All proposals for an emergency item should be accompanied by a brief explanatory memorandum and a draft resolution, which clearly define the scope of the subject covered by the request.

#### **WORK OF THE STANDING COMMITTEES**

All four Standing Committees will meet during the 132<sup>nd</sup> IPU Assembly.

The Standing Committee on Peace and International Security will be discussing and adopting a resolution on *Cyber warfare: A serious threat to peace and global security.* 

The Standing Committee on Sustainable Development, Finance and Trade will be discussing and adopting a resolution on the issue of *Shaping a new system of water governance: Promoting parliamentary action on water.* 

The Standing Committee on Democracy and Human Rights will finalize negotiations started during the 131<sup>st</sup> Assembly on the draft resolution entitled *International law as it relates to national sovereignty, non-intervention in the internal affairs of States and human rights.* The Standing Committee will also hold debates on other issues on its agenda.

The Standing Committee on United Nations Affairs will hold hearings and panel discussions based on the recommendations of its Bureau.

The draft agendas of the Standing Committees are attached. The agenda of the Committee on United Nations Affairs will be circulated at a later stage, after its Bureau meeting in New York on 21 November.

The summary record of the proceedings of the Standing Committee on Democracy and Human Rights at the 131<sup>st</sup> IPU Assembly, accompanied by the revised draft resolution and the note on the finalization of the text, are also attached.

Members are invited to actively participate in the proceedings of the Standing Committees. Moreover, it is important for all Bureaux members to attend the Hanoi Assembly as part of their national delegations.

A joint meeting of the Presidents of the Standing Committee Bureaux and of the Geopolitical Groups is also foreseen on Saturday, 28 March from 11.30 a.m. to 1 p.m. The <u>Presidents and Vice-Presidents of the Standing Committees</u>, as well as the Chairs of the Geopolitical Groups, are invited to attend this important meeting.

Documentation pertaining to the work of the Assembly, Governing Council, Standing Committees and other IPU bodies, as well as to other events taking place during the 132<sup>nd</sup> Assembly, will be made available on the IPU website at: www.ipu.org/conf-e/132agnd.htm

#### **PARTICIPATION**

IPU Members may appoint a maximum of eight delegates, or 10 for parliaments of countries with a population of 100 million inhabitants or more. Please note that the number of additional MPs accompanying delegations as Advisers must not exceed two.

All Member Parliaments are encouraged to strive for gender parity in the composition of their delegations. Any delegation which, for three consecutive sessions of the Assembly, is composed exclusively of parliamentarians of the same sex, shall automatically be reduced by one person.

Member Parliaments are also encouraged to include young members of parliament in their delegation. A meeting of the Forum of Young Parliamentarians of the IPU will be held on 29 March 2015. Among other things, the Forum will formulate and provide an input to the deliberations of the Assembly.

IPU Members whose arrears equal or exceed the amount of the contributions due from them for the preceding two full years shall not be represented by more than two delegates at meetings of the IPU (Article 5.2 of the Statutes).

Associate Members may participate in the Assembly and its Standing Committees with the same rights as Members, with the exception of the right to vote and to present candidates for elective office.

International organizations and other bodies invited by the Governing Council to be represented at the Assembly as Observers are entitled to send a maximum of two delegates.

Delegates are kindly requested to take note of the fact that the Plenary Hall, where the meetings of the Assembly and Governing Council are held, has limited seating capacity. Depending on actual attendance at the 132<sup>nd</sup> Assembly, the Secretariat will endeavour to allocate an adequate number of seats for all delegations. At a minimum, each delegation will be allocated a sufficient number of seats required for a possible vote by the Assembly or Governing Council.

#### STEERING COMMITTEE

The Steering Committee of the Assembly is composed of the President of the Assembly, the President of the Inter-Parliamentary Union and the Vice-President of the Executive Committee. The Presidents of the Standing Committees may take part in its work in an advisory capacity.

The Steering Committee, assisted by the IPU Secretary General, is mandated to take all appropriate measures to ensure the effective organization and smooth running of the Assembly proceedings. The first sitting of the Steering Committee is scheduled for Sunday, 29 March 2015, early in the morning.

#### VACANCIES TO BE FILLED DURING THE 132<sup>nd</sup> ASSEMBLY

A provisional list of vacancies for IPU bodies will be posted on the IPU website, three months prior to the opening of the Hanoi Assembly; an updated version will be circulated to Members six weeks ahead of the event.

#### PREPARATION OF DRAFT RESOLUTIONS AND SELECTION OF AGENDA ITEMS

All Members can contribute to the drafting of resolutions by submitting a brief written input (Article 13.1 of the Rules of the Standing Committees). The deadlines pertaining to the preparation of resolutions for the Standing Committee on Peace and International Security and the Standing Committee on Sustainable Development, Finance and Trade are the following:

7 December 2014	Deadline for Member Parliaments to submit written input to the draft resolutions (max. 2 pages) – see previous communication at <a href="https://www.ipu.org/conf-e/132agnd.htm">www.ipu.org/conf-e/132agnd.htm</a>
9 January 2015	Deadline for the co-Rapporteurs to submit the draft resolutions and explanatory memorandum to the IPU Secretariat.
13 March 2015	Deadline for Member Parliaments to submit written amendments to the draft resolutions.
29-31 March 2015	Committees debate, amend and adopt the draft resolutions. Co-Rapporteurs present the draft resolutions and provide advice during the drafting process.
1 April 2015	132 <sup>nd</sup> IPU Assembly formally adopts the resolutions.

Please note that no input or new amendments will be received for the Standing Committee on Democracy and Human Rights on the draft resolution entitled *International law as it relates to national sovereignty, non-intervention in the internal affairs of States and human rights.* Work will continue in Hanoi based on the agreement reached during the previous Assembly in Geneva (October 2014).

In accordance with the amended Rules of the Standing Committees, proposals for subject items to be taken up by Standing Committees need to be submitted no later than 15 days before the opening of the Assembly preceding the one where the subject will be discussed. As such, Members are encouraged to submit to the IPU Secretariat by 13 March 2015 at the latest their proposals for subject items to be taken up by the Standing Committee on Peace and International Security and the Standing Committee on Sustainable Development, Finance and Trade.

#### **GENERAL DEBATE (Item 3 of the agenda)**

As indicated in the agenda, the General Debate at the 132<sup>nd</sup> Assembly will focus on the overall theme of *The Sustainable Development Goals: Turning Words into Action.* 

In accordance with the Assembly Rules and unless the Steering Committee decides otherwise, every delegation shall be entitled to eight minutes' speaking time in the General Debate. When two speakers from the same delegation are registered for the Debate, speaking time will be shared as appropriate.

By decision of the IPU Governing Council, the speaking time of Observers will be limited to five minutes. Flexibility will be shown in the case of executive heads of organizations within the United Nations system who wish to address the IPU.

Registration will take place at the speakers' registration desk, situated just outside the main entrance to the Plenary Hall (Banquet Hall) on the first floor of the National Convention Centre. This desk will open 24 hours before the beginning of the first plenary of the Assembly, on Saturday, 28 March at 11 a.m.

Members may also send the names of their speaker(s) in advance to the IPU Secretariat by e-mail or fax, using the attached "Speakers pre-registration form" (Annex 2).

Pre-registration will be considered valid once the final order of speakers has been determined by the traditional public drawing of lots at 6 p.m. on Saturday, 28 March 2015 (cf. Art. 23.2 of the Rules of the Assembly).

#### **VICE-PRESIDENTS OF THE ASSEMBLY**

According to Rule 7.3 of the Assembly Rules, all delegations from Member Parliaments are entitled to designate one of their members as a Vice-President of the Assembly. Some of them will be called upon to replace the President of the Assembly during a sitting or part of a sitting.

Upon arrival at the IPU Registration Desk in Hanoi, delegations are invited to indicate the name of the parliamentarian nominated as a Vice-President of the Assembly. Alternatively, names may be handed into the Documents Submission and Control Service (office 202C, on the second floor of the NCC), by Sunday, 29 March 2015, at the latest.

#### TABLE SHOWING THE ALLOCATION OF VOTES

A provisional table showing the votes allocated to delegations to the 132<sup>nd</sup> Assembly is contained in Annex 3.

Members are kindly requested to check the figures concerning them and, if necessary, inform the IPU Secretariat in Geneva in writing of any modifications required, preferably ahead of the session. The final table showing the allocation of votes at the Assembly will be distributed at the opening of the session.

#### **LANGUAGES**

The IPU Secretariat will provide simultaneous interpretation into and from its two official languages: English and French, as well as Arabic and Spanish, at the meetings of all statutory bodies.

Four other interpretation channels have been reserved for Chinese, Japanese, Portuguese and Russian at sittings of the Assembly and the Governing Council, and for some sessions of the Standing Committees. These booths are provided free of charge and may be used by the interpretation teams of these languages, if the parliaments concerned choose to do so.

Delegates may, exceptionally, use another language provided that they arrange for their speech to be interpreted into one of the IPU's official languages by a member of their delegation who will be given access to an interpretation booth. To allow for all necessary arrangements to be made in good time, delegations should contact, well in advance, the Chief Interpreter (Ms. F. Steinig-Huang) or the English booth interpreters assigned to the meeting at which the speech will be delivered. Moreover, eight copies of a translation of the speech into one of the IPU's official languages should be given to the Chief Interpreter or to the English booth for distribution to the other interpreters.

The Association of Secretaries General of Parliaments (ASGP) will also meet at the NCC during the Assembly. It will be convened by its President.

#### **RESULTS OF THE ASSEMBLY**

All delegations will receive two printed copies of the *Results* of the 132<sup>nd</sup> Assembly. In addition, the document will become accessible on the IPU website two weeks after the close of the Assembly, when a complete electronic version can be downloaded in PDF format.

#### **ADDITIONAL INFORMATION**

Further information concerning the session will be provided in the Assembly Guidebook, distributed to delegations upon registration in Hanoi. During the Assembly, a daily Journal will also be available, providing the latest updates on the programme of meetings and other important information.

#### **REGISTRATION**

#### All delegations are requested to respect the registration deadline of 28 February 2015.

All Members are encouraged to use the IPU online registration system. Annex 4 provides instructions on how to use the system, which will be operational as of 1 December 2014. Please note the recommendation that only one person be designated as the delegation coordinator and have access to the system.

## **Explanatory note on IPU online registration**

The IPU Secretariat online registration system can be accessed through the IPU website, on the 132<sup>nd</sup> Assembly page, simply by clicking on the Registration button. The system will be open from 1 December 2015 and will close on 24 March 2015, after which delegates should register with the IPU registration service: registration@ipu.org.

**Important**: It is recommended that all participants designate one delegation coordinator, who will be the sole user of the online registration system and will choose a password.

The registration process is as follows:

- Sign up for an account and enter the requested details on this page. If you registered successfully for either the 130<sup>th</sup> Assembly in March 2014 or the 131<sup>st</sup> Assembly in October 2014, your identification information is still valid and may be used.
  - If the IPU Secretariat has opened an account on your behalf using your parliament's official e-mail address, you are invited to contact the IPU at registration@ipu.org for more information.
- 2. Once you have successfully created an account, sign in using your user name and password.
- 3. Click on "Register for this event" to register for the 132<sup>nd</sup> Assembly.
- 4. Click on "Start registration" to register your delegation. In your capacity as delegation coordinator, do not forget to include yourself if you plan to attend the event.
- 5. Please ensure that all information relating to membership in IPU governing bodies and committees is included under: "Title or function within the IPU"; details pertaining to your national parliament should be included under: "Title/function in Parliament/Organization".
- 6. It will be possible to make changes to your data until 24 March 2015, after which you should contact the IPU directly at <a href="mailto:registration@ipu.org">registration@ipu.org</a>.

The registration process includes a **validation phase**, during which system administrators will examine your registration. Once your registration has been validated, you will be sent a confirmation e-mail. Otherwise, one of our administrators will contact you for any action that requires follow-up.
