To this end, the character and regional action of the ECOWAS Parliament eminently qualify it to perform such a function. In addition to sharing and capitalizing on national experiences, this seminar will also examine all possible ways for this regional institution to play the required uniting role with a view to addressing these scourges collectively through a regional approach.
