In view of the measures implemented in West and Central African countries and recognizing the need to harmonize strategies, the seminar will also examine the possibility of interregional cooperation between West and Central Africa, thus providing for concerted, identical and targeted responses that will, over time, reduce the room for manoeuvre of traffickers in the two sub-regions.

4. ARRIVAL AND DEPARTURE

AGENDA

Session 1: Brief overview of the activities already undertaken and their impact on the fight against forced labour (and in particular trafficking) and child labour

This session will provide a background for the discussion through a brief review of previous activities, namely the regional seminar in Abuja in June 2012 and the workshop in Turin (organized by the ILO) in December 2014, during which parliamentary actions were recommended to ensure effective handling of the issue of child trafficking and labour.

This session will also provide participants with an opportunity to ascertain the impact of these successive activities on the management of this problem in different countries of the subregion. It will finally make it possible to highlight and remedy shortcomings identified in the implementation of those recommendations.

Session 2: Identification and examination of national and regional synergies in the fight against forced labour (and in particular trafficking) and child labour and strengthening South-South cooperation among parliaments

No country can remain indifferent to the continued existence of forced labour and child trafficking and labour considering the impact of these scourges on the future of the next generation. Some of the initiatives implemented are yielding tangible results in reducing child trafficking and labour. However, the many synergies that exist at the national and regional levels can be made more effective through an approach based on cooperation and harmonization for more targeted action.

This session will be devoted to identifying national and regional synergies – including those of the Central African Economic and Monetary Community (CEMAC). Their examination will help to raise awareness of good practices in other countries and make it possible to categorize and harness synergies with a view to developing sound strategies to guide future parliamentary action.

Session 3: ECOWAS, catalyst and relay for initiatives to promote the eradication of child trafficking and labour: The crucial role of its Parliament

ECOWAS is at the heart of the system providing for the gradual eradication of child trafficking and labour. Efforts have indeed been made, notably through:

- i) The Multilateral Cooperation Agreement to combat child trafficking in West Africa;
- ii) the Multilateral Regional Cooperation Agreement to Combat Trafficking in Persons especially women and children in West and Central Africa, and
- iii) The ECOWAS Regional Action Plan for the elimination of child labour especially its worst forms.

However, given the continued existence of this scourge that is difficult to control, ECOWAS, in line with its regional action plan mentioned above and the peer review mechanism for which some pilot actions were undertaken in 2014 is committed to further supporting national actions against child trafficking and labour. In accordance with a gradual eradication of this scourge, ECOWAS should continue supporting bilateral initiatives as a first step prior to large-scale collective action.

During this session, participants will be informed as to how the ECOWAS mechanism is working to combat forced labour (in particular trafficking) and child labour. Participants will then be given the opportunity to identify the contribution that the ECOWAS Parliament should make to the implementation of this mechanism. This contribution is all the more critical as the Parliament is in the midst of a transition from a consultative status to a legislative status. Once the transition is complete, the Parliament will be given new prerogatives to deal effectively with this issue through the adoption of appropriate legislation and the allocation of resources necessary to implement agreed actions, for which it will provide follow-up.

Session 4: Collaboration and support of all actors concerned for concerted and target action

Besides governmental action and the consultation of the legislators in view to coordinating their actions, the eradication of child trafficking and labour requires also the support of social partners (employers' organization, organization of workers) NGOs and others actors from civil society and international organisations. Particular emphasis will be placed on promoting the ratification of the 2014 Protocol to the ILO Forced Labour Convention. Special attention will be given to the global partnership to achieve target 8.7 on the eradication of child labour and forced labour under Sustainable Development Goal 8 concerning the promotion of decent work. Civil society and NGOs are also close to populations and see first-hand their daily lives. They therefore constitute a better channel for disseminating information and raising awareness in connection with the development and implementation of key actions to combat trafficking and child labour. The contribution of international institutions, defined in terms of expertise and financial support, will serve to strengthen the efforts needed for the large-scale collective actions recommended.

During this session, all possible ways of establishing or reinforcing South-South and triangular cooperation, as well as between the different actors involved will be examined, from which parliamentarians will benefit greatly.

Session 5: Identification of priorities and of the strategy for their implementation

Clearly, the continued existence of child labour and trafficking and the damage that they cause render all actions urgent. However, while a comprehensive approach should be adopted, it should also be able to define the actions to be taken in order of priority with realistic timeframes.

During this session, priorities will be identified, as will the actors responsible for their implementation, the resources required, and the timelines involved.
