Arrangements for the conduct of the Conference

6. The conference will be organized in plenary sessions and smaller parallel sessions. Each session will be launched by speakers who will make introductory remarks. Delegates can participate in the debate either by making brief comments or by asking questions. In view of the largely informal nature of the debate, no list of speakers will be drawn up in advance. A moderator will guide the debate and decide the order of interventions and questions. On the morning of 3 November, a field visit will be organized in San Juan Chamula, approximately one hour from Tuxtla Gutiérrez, where participants will hold a discussion with traditional and constitutional indigenous leaders.

Languages

7. Simultaneous interpretation will be provided in English, French and Spanish. Official written documentation of the Conference will be available in English, French and Spanish.

Documents

- 8. The only official documents of the Conference will be the agenda, List of Delegates, discussion papers prepared by the speakers and the information notes prepared by the Conference Secretariat.
- 9. Should participants and observers wish to distribute their own documents or other material pertaining to the theme of the Conference, they may use a table provided for that purpose in the immediate vicinity of the meeting room.

Visas

- 10. Strict regulations are in force regarding entry into Mexico and entry is refused to persons not holding the required visa. Delegates requiring an entry visa must obtain one from the Mexican consulate or diplomatic mission in their country of residence. It is strongly recommended to delegates to take the necessary steps in order to obtain their visas as soon as possible. Please note that citizens of some countries are required to have an entry visa (not a transit one) for the United States when they land in a US airport on the way to Mexico.
