10.30 am Session 1- Migrant women: more vulnerable to gender-based violence

A review will be undertaken of the factors that heighten the vulnerability of women migrants to genderbased violence: discrimination based on gender or origin, isolation, precarious situation, dependence on employer or (former) intimate partner, status under immigration laws (migrant women who arrive in Europe on the grounds of family reunification, undocumented migrant women or those who risk losing their status of immigrant), etc. The obstacles encountered by women migrants who are victims/survivors of violence in accessing emergency and protective services, the justice system and rehabilitation facilities will also be examined. A special focus will be given to the violence faced by migrant women at different stages of migration.

2.30 pm Session 2 - Gender-based violence and persecution, grounds for international protection: what implementation in Europe?

Sexual violence in armed conflicts, female genital mutilation, forced marriages, domestic violence and other affronts to physical and psychological integrity drive women to flee their countries of origin. These forms of gender-based persecution can constitute grounds for asylum. What is the reality of the situation? The Guiding Principles on Gender-Related Persecution published by the United Nations High Commissioner for Refugees in 2002 and their implementation by European States will be examined as well as how to incorporate a gender-sensitive perspective in the asylum-seeking process.

4.30 pm Session 3- Protecting migrant women from trafficking in human beings

At the heart of trafficking in human beings, there are significant gender disparities because 80 per cent of victims are women and girls, mostly exploited in prostitution or forced labour networks. The scale of this problem and implementation of regional and international instruments to combat this scourge will be examined. The role of parliamentarians in ensuring proper implementation and following up progress made, with a special focus on the Council of Europe Convention on Action against Trafficking in Human Beings and other international instruments, will also be addressed.

2.30 pm Session 6 - International cooperation and extra-territorial protection of women and girls normally resident in Europe against practices contrary to human rights

This session will be dedicated to the crucial role of bilateral, regional and multilateral cooperation in combating violence against women, including in judicial areas, to prosecute the perpetrators, but also to promote the prevention, protection and assistance to victims/survivors. It will examine extraterritorial legislative provisions aimed at protecting women and girls normally residing in Europe from violence they have suffered or risk suffering in their country of origin. In this context, the session will look at the added value of the extraterritorial provisions envisaged in the future Council of Europe convention on preventing and combating violence against women and domestic violence.
